## 2021 PIGS - WHAT'S NEW

This summary is provided as a courtesy **only**, and should not be substituted for reading the Schedule in its entirety.

- The first day of the Sydney Royal Easter Show (1 April 2021) will be used as the reference date for all Classes.

- In 2021, the minimum entries for a Breed Class have changed. If there are 3 or more Exhibitors with at least 2 of these Exhibitors having 5 or more pigs in any one breed, a Competition will take place within that breed.

- Pigs shall be allowed on and off the Showground during the following dates and times. **These times will be strictly enforced.** Exemptions to these hours can be granted by the Pig Committee **only**:

- Pigs shall be allowed onto the Showground from **7am Wednesday 31 March 2021**.
- All Exhibits must be penned on the Showground by **10am Wednesday 31 March 2021**.
- All pigs will be permitted to leave the Showground on **Tuesday 6 April 2021** between **5pm - 7pm**. Preference for loading will continue to be given to interstate Exhibitors, those travelling long distances, or those with medical restrictions on their travel.

- In 2021, onsite accommodation will be subject to NSW Health regulations and direction. Updated information, when available, will be published on the RAS website.

- Offline entries will attract a processing fee of \$25 per Exhibitor.

## CONDITIONS OF ENTRY

Exhibitors must adhere to the Conditions of Entry to Sydney Showground located at [www.rasnsw.com.au](http://www.rasnsw.com.au), the RAS General Regulations and the Special Sydney Royal Pig Regulations in this Schedule (the "Regulations").

A condition of entering into Competitions is strict adherence to the Regulations. Accordingly, Applications for Entry in the name of deceased Person(s) are not eligible for entry.

The Application for Entry and the Regulations constitute the whole agreement upon which Entries are submitted and the Exhibitor agrees that all representations and statements not appearing on the Application for Entry or in the Regulations are excluded.

The Exhibitor certifies that each animal exhibited by them or by their child/children/guardian is duly registered and either their property absolutely or is under their absolute care and control. The Exhibitor holds the RAS exempt from any liability in the event of any loss or damage from any cause whatsoever.

A refund of Entry Fees shall not be made unless a notification of withdrawal is received by the RAS Coordinator before the Closing Day of Entry.

The RAS has the power to evict any Exhibitor from the Showground.

## WORKPLACE SURVEILLANCE ACT

RAS operates surveillance cameras from Sydney Showground Security and these are located in and around facilities requiring security monitoring for the safety or security of individuals or property. RAS also has access to Sydney Olympic Park security cameras and vice versa. Please note that security camera monitoring is continuous and ongoing and it is deemed that a person, by entering the Showground, consents to this photographing, filming or taping. RAS strictly complies with the Workplace Surveillance Act 2005.

## WORKING WITH CHILDREN

Exhibitors must comply with all applicable Working with Children Legislation.

The Exhibitor agrees to produce on demand, at least 1 month before Competition, evidence of working with children checks for themselves, their employees or volunteers who are involved in a child-related role or have direct unsupervised contact with children.

## DISCLAIMER

The information contained in this publication is gathered for the purpose of providing information to our Exhibitors and Show patrons.

The information is a compilation of information provided by third parties and the RAS does not warrant its accuracy and advises that any such information may be subject to change or amendment occurring at any time and thereby making the information incorrect. Subject to the RAS' legal obligations and responsibilities. If you require confirmation of any information please telephone the RAS coordinator responsible for the particular information or the RAS switchboard on (02) 9704 1111.

## ACKNOWLEDGEMENT, RELEASE AND INDEMNITY

Exhibitors acknowledge and agree that they and their animals attend the Showground at their own risk. Exhibitors are responsible for arranging their own personal accident insurance, or insurance for their animal, as they feel is appropriate. There are indemnities in the RAS General Regulations which govern all Competitions on the Showground, please refer to the RAS General Regulations.

## PREVENTION OF CRUELTY TO ANIMALS

All Exhibitors are required to comply with applicable New South Wales legislation, including but not limited to the *Prevention of Cruelty to Animals Act 1979 (NSW)*, *Prevention of Cruelty to Animals Regulation 2012 (NSW)*, *The Prevention Of Cruelty To Animals (Land Transport Of Livestock) Standards 2013 (NSW)*.

*An Exhibitor or nominated person shall at all times exercise reasonable care, control or supervision of their animal. An Exhibitor or nominated person who brings an animal to the show, shall have a duty of care for their animal and to the community. This includes the comfort, safety and welfare of their animal and the interactions of any animal, and with any other person or animal, at any time, whilst on-site at the show. As a public show, Exhibitors acknowledge that all animals exhibited do not pose a danger to other animals or the show community and consider the welfare of their animal prior to deeming it suitable for Exhibition.*

### Handling

*Where the person is handling the animal they shall not act in a manner which unreasonably, unnecessarily or unjustifiably inflict pain upon the animal. This includes acts that are deemed physical or psychological abuse.*

## PRIZES AND GST

The Australian Taxation Office has deemed that GST is payable on prizes if an Exhibitor is registered for GST and enters an Exhibit as part of a business enterprise.

The information an Exhibitor provides on the Application for Entry determines whether GST is applicable.

*Any prize stated in this Schedule does not include GST.*

### GST will not apply:

- if an Exhibitor enters an Exhibit as a hobby or private recreational pursuit; or
- if an Exhibitor enters an Exhibit as part of a business enterprise, the Exhibitor has an ABN, but the Exhibitor is NOT REGISTERED for GST.
- if an Exhibitor enters an Exhibit as part of a business enterprise the Exhibitor is not entitled to an ABN as the business or enterprise is not operating in Australia.

### GST will apply:

- if an Exhibitor enters an Exhibit as part of a business enterprise, the Exhibitor has an ABN, and the Exhibitor is REGISTERED for GST.

Where GST applies, the RAS will pay the prize money quoted in this Schedule plus 10% GST. The RAS will issue a recipient created tax invoice.

**WARNING:** *The Exhibitor must complete the Tax Details on the Application for Entry. Failure to do so will result in the RAS deducting 47% of the successful Exhibitor's prize money as Pay As You Go Tax (PAYG). The RAS recommends that the Exhibitor seeks professional advice before completing the Tax*

## ACCOMMODATION

Due to the evolving situation with respect to COVID-19, on-site accommodation arrangements may change. More information about on-site accommodation will be communicated with exhibitors closer to the 2021 Show.

To apply to stay in a site shed or a mezzanine room, keep an eye on the RAS website for information and updates.

## ACCESS TO THE SHOWGROUND

After Applications for Entry have been received and accepted by the RAS, and prior to the Show, Exhibitors will receive an Exhibitor Pack containing all materials they require to exhibit at the Show. To gain access to the Showground when delivering Exhibits, all vehicles must present the bump-in pass and show entry pass/ticket for each occupant in the vehicle to Security personnel.

A Dashboard Slip will also be issued to Exhibitors with the Showtime Authorised Contact Person's mobile number printed on the slip. A Dashboard Slip must be displayed on the dashboard of each vehicle at all times while on the Showground.

**NO VEHICLE WILL BE ALLOWED TO PASS THROUGH SHOWGROUND GATES WITHOUT A BUMP IN/BUMP OUT PASS AND A VALID ENTRY PASS/TICKET FOR EACH OCCUPANT IN THE VEHICLE.**

## REGISTRATION CERTIFICATES

Registration certificates are required and must be presented at Inspection of Exhibits. Copies of registration certificates are not required to be submitted with Application for Entry. **Please do not post or send registration certificates to the RAS.**

## TIME OF ARRIVAL

**Wednesday 31 March 2021, between 7am and 10am.**

All Exhibits must be penned on the Showground by 10am on Wednesday 31 March 2021. Exemptions to these hours can be granted by the Pig Coordinator only.

**All stock must be unloaded from vehicles as soon as possible on arrival. The vehicle once unloaded must immediately leave the Showground.**

## PAVILION OPENING TIMES

The Paddington Pavilion will be open to the public at the following times, **except on changeover days:**

From 9am to 7pm, Thursday 1 April to Monday 12 April 2021.

The Paddington Pavilion Coordinator's Office shall be open for Exhibitor Enquiries from 8am - 5pm.

## INSPECTION DAY

Pigs will be inspected on Friday 2 April 2021, at 8.30am.

## JUDGING DAY

Judging will take place on Saturday 3 April from 8.30am.

## TIME OF DEPARTURE

All pigs will be permitted to leave the Showground on Tuesday 6 April 2021 between 5pm - 7pm. Preference for loading will be given to interstate Exhibitors and others or those travelling long distances, or those with medical restrictions on their travel.

Please note, Exhibitors are encouraged where possible to stay the length of the Show to bolster Exhibit numbers.

## DATES OF BIRTH FOR CLASSES RESTRICTED BY AGE

Stated hereunder is an explanation regarding Classes which restrict the eligibility of an Exhibit by the fact of its age. The dates shown within the parenthesis are those on, or between which, the Exhibit must be born to enable it to compete in the Class referred to immediately preceding the parenthesis.

Age of pigs (litter Classes excepted) to be calculated from the birth date shown in the registration in the herd book up to 1 April 2021

**1 April 2021 will be used as the reference date for all Classes.**

- 18 months and older  
(on or before 1 October 2019)
- 12 months and under 18 months  
(2 October 2019 - 1 April 2020)
- 12 months and older  
(on or before 1 April 2020)
- 9 months and under 12 months  
(2 April 2020 - 1 July 2020)
- 7 months and under 9 months  
(2 July 2020 - 1 September 2020)
- 6 months and under 7 months  
(2 September 2020 - 1 October 2020)
- 4 months and under 6 months  
(2 October 2020 - 1 December 2020)
- Litter not over 6 weeks old  
(farrowed on or after 18 February 2021)

## UNDER 12 MONTHS OLD CLASSES

Exhibits entered in these Classes must conform with the following conditions:

- (a) Sire and Dam pigs under 12 months of age must be recorded with an Australian pig breeders association or a branch of same.
- (b) Exhibitors may nominate a maximum of **four** litters per Class.
- (c) Exhibitors may enter a maximum of **four** pigs per Class from the nominated litters.
- (d) Provided a litter has been nominated for entry in accordance with the Special Regulations, any pig from that litter will be eligible for Exhibition in the under 12 months Classes. Exhibitors must supply the following information on the Application for Entry for each litter nominated from which an Exhibit may be entered:

- (g) **A Litter Confirmation note will be supplied by the RAS to be completed by the Exhibitor and returned no later than 5pm on Wednesday 17 March 2021.**
- (h) Each confirmation of nomination must include the following information:

- (i) If a pig from a nominated entry is not registered or recorded by Wednesday 17 March 2021 the Exhibitor must present the breed association registration/recorded certificate of both the sire and the dam at the inspection of Exhibits.
- (j) **If an Exhibitor does not confirm the individual entries from the nominated litters in accordance with this Special Regulations then the only pigs eligible for entry will be from the first litter nominated.**



## PERPETUAL TROPHES

Perpetual Trophies remain the property of the Royal Agricultural Society of NSW. Ownership of the Trophy does not pass to the winning Exhibitor. A medallion will be presented to the annual winner whose name will be engraved on the Trophy.

## SUPPORTER PRIZES

Prizes are provided by third parties and the RAS advises that any such Prize may be subject to change or amendment occurring at any time, thereby making the original information published incorrect.

## SPECIAL PIG REGULATIONS

The RAS General Regulations apply to all sections of the Show. These Special Pig Regulations apply to this Section only. Unless expressly stated in the RAS General Regulations, if there is any inconsistency between the General Regulations and these Special Pig Regulations, the Special Pig Regulations prevail. All Regulations available from [www.rasnsw.com.au](http://www.rasnsw.com.au).

## INTERPRETATION

1. In these Regulations, unless there be something in the subject or context inconsistent therewith:

**Group A** means the following pig breeds may enter:

- Large White
- Landrace
- Duroc
- Hampshire

**Group B** means the following pig breeds may enter:

- Berkshire
- Wessex Saddleback
- Tamworth
- Large Black

**Exhibitor** means the Person on whose behalf and in whose name the Application for Entry is lodged with and accepted by the RAS and includes the representatives and agents of an Exhibitor.

**Person** includes a firm, partnership, company or corporation.

**Show Society** means a country pastoral and agricultural society or association.

**RAS** means the Royal Agricultural Society of New South Wales.

## AGE OF PIGS

2. Age of pigs (litter Classes excepted) to be calculated from the birth date shown in the registration in the herd book up to 1 April 2021. The age of pigs in litter Classes shall be actual age at the date of judging.

## ALL EXHIBITORS ENTERED IN STUD PIG CLASSES PLEASE NOTE:

3. (a) The Committee reserves the right to combine or split breed Classes at its discretion subject to the final number of entries received at the closing date of entry within each breed.
- (b) If there are 3 or more Exhibitors with at least 2 of these Exhibitors having 5 or more pigs in any one breed a Competition will take place within that breed.
- (c) **Group A** consists of the following breeds:
  - Large Whites
  - Landrace
  - Duroc
  - Hampshire

**Group B** consists of the following breeds:

  - Berkshire
  - Wessex Saddleback
  - Tamworth
  - Large Black

## ATTIRE

4. Every Attendant on judging and inspection days must be suitably attired in clean, white coats with boots or strong shoes. Dustcoats must in no way show any insignia or descriptive message.  
Any Exhibitor or person attending to animals, including washing must wear appropriate footwear at all times, to avoid injury.

## BREEDING PARTICULARS

5. The registration certificate of a boar or sow entered in a Class for Exhibits born before 18 February 2021 must be furnished at time of inspection.

For a boar or sow entered in a Class for Exhibits born on or after 18 February 2021 its registration or recorded certificate must be furnished at time of inspection.

**Full and correct particulars** must be stated on the Application for Entry, where applicable.

Failure to observe these provisions will automatically cancel the entry.

## CARE AND CONTROL OF EXHIBITS

6. All pigs shall be fed and attended by the Exhibitor, who shall be responsible for the cleanliness and proper condition of the pens while the pigs remain on the Showground, and shall be subject to the control of the Superintendent of the section appointed by the RAS.

All Exhibits must be fed and pens cleaned out by 7am daily.

In the event of any pig being unfed, or any pen being in improper condition at any time while the pig remains on the Showground, the Officials of the RAS shall feed and attend to the pig. The cost of such feed and attendance shall be borne by the Exhibitor of the pig.

Any Exhibitor who neglects to feed and properly attend to all pigs during the period through which they remain in the pens, shall be liable to disqualification after enquiry by the Committee.

No pig shall be moved from its numbered pen without the sanction of the Superintendent.

Every Exhibitor will be deemed to be, and will be held responsible for the condition in which his Exhibit appears in the pen.

## CHAMPIONSHIPS

7. First and second prize sows in litter Classes may compete individually for Senior Championship and Reserve Senior Championship prizes as defined hereunder. In awarding the Championship, the first prize-winners of the relative sex in each Class of the relative Subsection shall be eligible to compete.

In awarding the Reserve Championship, the first prize winner in each Class in the relative Subsection, other than the Exhibit to which the Championship has been awarded, shall be eligible to compete, together with the second prize winner in the Class in which the Champion was awarded first prize.

In awarding the Junior Championship, the first prize winner of the relative sex in each Class of the relative Subsection shall be eligible to compete provided that no Exhibit shall be eligible to compete for the Junior Championship if it is over 12 months old.

In awarding the Reserve Junior Championship, the first prize winner in each Class in the relative Subsection, other than the Exhibit to which the Junior Championship has been awarded, shall be eligible to compete, together with the second prize winner in the Class from which the Junior Champion was drawn, provided that no Exhibit shall be eligible to compete for the Reserve Junior Championship if it is over 12 months old.

## DISCIPLINARY MATTERS

8. Refer to the RAS General Regulations.

## ELIGIBILITY OF ENTRY

9. (a) All pigs over 12 months of age entered in Stud Classes must be registered with an Australian pig breeders association in order to confirm the integrity of the breed stock.
- (b) All pigs under 12 months of age must be **recorded** with an Australian pig breeders association in order to confirm the integrity of the breed stock.
- (c) No pig shall be entered for a Class for which it is not eligible on account of age. Exhibitors may be disqualified and debarred from further Competition for any breach of this by-law.
- (d) No sow or boar over 18 months of age shall be eligible to compete unless the date of farrowing of the last progeny produced is shown on the Application for Entry.
- (e) All pigs Exhibited with a sow shall be her own progeny and not exceeding six weeks old on Saturday 3 April 2021.
- (f) Any sow entered in a sow and litter Class, which has not farrowed at the time of judging, may compete in a dry Class or vice versa. Such transferred entry shall be additional to any entries made by the Exhibitor in the relative Class. The Exhibitor must advise the Pig Coordinator as early as possible to enable the transfer to be effected before the time of judging.
- (g) Any Exhibitor under 12 years of age to be accompanied by a Person over 18 years. **All boars** to be paraded by Persons over the age of 18 years.
- (h) **All boars over the age of 6 months must have their tusks cut back to gum level within two weeks prior to the first day of the Show. Any boar, which in the opinion of the Inspectors on inspection day, is a danger, shall have its tusks cut back to gum level and may be eliminated from showing.**

## EXHIBIT UNWORTHY OF AWARD

10. An Exhibit shall not receive an Award if in the opinion of the Judge it is unworthy of such Award.

## EXHIBITS AND JUDGES

11. An Exhibitor shall not Exhibit an animal, which the Judge directly or indirectly owned or leased alone or jointly with another, or which he handled within six (6) months preceding the date of the Show.

**An Exhibit shall be deemed to be owned by or to be leased to a Judge if it is an Exhibit in which, at any time during the preceding 6 months, he or his spouse, his children, parents, brothers, sisters, or their children or the parents of his spouse, their children or grandchildren, or in any case any one or more of them, have any interest.**

12. (a) A Judge shall not:
  - (i) Judge an Exhibit, which he directly or indirectly owns or leases alone or jointly with another;
  - (ii) act as a handler of an Exhibit or Exhibit an animal at a Show at which he officiate as a Judge,
  - (iii) knowingly Judge an Exhibit Exhibited contrary to Special Regulation 12.
- (b) An Exhibit shall be deemed to be owned by or to be leased to a Judge if it is an Exhibit in which at any time during the preceding 6 months, he or his spouse, his children, parents, brothers, sisters or their children or the parents of his spouse, their children or grandchildren or in any case any one or more of them, have any interest.
- (c) An Exhibit causing or likely to cause a contravention of this Special Regulation shall be disqualified with effect from the commencing day of the Show.

## EXHIBITION PASSES

13. Exhibitors will be allocated passes as follows:

1 - 4 pigs	1 pass
5 - 8 pigs	2 passes
9 - 15 pigs	3 passes
16 pigs or more	4 passes

\* Please Note: **NO** extra passes other than those allocated as per the above specification will be issued.

## FODDER

14. (a) The RAS provides an Official Produce Merchant for the sale of Fodder on the Showground prior to, during and after the Show closes. The fodder store on the Showground shall be open for the receipt of orders from 5 days prior to the first day of the Show and until the last day of the Show.
- (b) No other Person, firm or company shall be allowed to sell on or deliver Fodder to the Showground at any time.
- (c) It shall be the responsibility of the Exhibitor to arrange for his/her Fodder requirements with the Official Produce Merchant, who will carry all proprietary lines of pre-mixed feed, as required.
- (d) Home grown Fodder brought exclusively for an Exhibitor's own use shall not be admitted to the Showground after arrival on penning date.
- (e) An Exhibitor found, to the satisfaction of the Committee, to be selling Fodder to any other Exhibitor shall be reported to the Committee who shall take whatever action is thought necessary.
- (f) The Official Produce Merchant shall report to the RAS any breach of these Regulations coming to his notice.

## HOSPITAL PENS

15. An Exhibitor of person attending to animals who requires the use of a Hospital Pen for sick or pregnant stock is requested to apply to the Pig Coordinator.

## IDENTIFICATION OF EXHIBIT

16. All markings must be clear and well healed prior to inspection. If in the opinion of the appointed Inspectors any animal is not clearly identifiable in accordance with the Rules and Regulations of the Australian Pig Breeders Association, the said animals shall be disqualified.  
Exhibits must be branded with their catalogue number prior to inspection. Exhibits not so marked may be disqualified.  
Exhibits must have their catalogue number affixed to the pen prior to inspection.

## INSPECTOR'S VERIFICATION OF TYPE, DESCRIPTION AND ELIGIBILITY

17. (a) Each animal shall be subject to inspection commencing at 8.30am of the day immediately preceding judging day by an Inspector or Inspectors appointed by the RAS.  
Order and approximate time of inspection will be advised by the Steward-in-Chief or Assistant Steward-in-Chief and Exhibitors shall be required to stand by their Exhibits during inspection.
- (b) If any such inspector shall certify that in his opinion:
- (i) the animal is not true to type; or
  - (ii) is not of such description or merit as to be a worthy Exhibit in the Class or Classes in which it is entered; or
  - (iii) such animal bears any marking, whether in the nature of colour, tattoo, fire or other brand, surgical operation, or otherwise contrary to the markings disclosed in the relative Application for Entry, or does not show some such markings attributed to it in the relative Application for Entry. If any such marking or absence of marking is not in accordance with the particulars furnished in respect of such animal by the relative breed society; the RAS may require the animal to be forthwith removed from the Showground and the Exhibitor, upon receipt of such notice, shall forthwith remove such animal and failing such removal by him within the time prescribed by the Steward-in-Chief, the Steward-in-Chief may remove the animal or cause the animal to be removed and all costs and expenses of removal shall be borne by the Exhibitor and shall be refunded to the RAS. Each such animal shall at all times be at the sole risk and responsibility of the Exhibitor and the Person or Persons removing the animal shall at all times be deemed to be agents of the Exhibitor and all acts and omissions on the part of such Person or Persons shall be deemed to be the acts and omissions of the Exhibitor who shall indemnify and hold indemnified the RAS its servants and agents from all claims whatsoever in respect of the animal whether by reason of any loss or injury to or caused by the animal or because of transportation, feeding or housing or otherwise howsoever.
- (c) No inspector shall be required to furnish to the Exhibitor any reasons for his determination nor shall there be any appeal against such determination. The Steward-in-Chief or Assistant Steward-in-Chief of the Pig Section of the particular Class in which such animal is entered for Exhibition may override any such determination and permit the animal to remain on the Showground with or without the right of being paraded and/or Exhibited.

## ONLY EXHIBITS TO BE BROUGHT ON TO GROUND

18. No animal other than an Exhibit in respect of which Application for Entry has been accepted by the RAS shall be brought on to the Showground by any Exhibitor or other Person except with the consent of the Steward-in-Chief.  
No animal other than an Exhibit shall be displayed or exposed for sale on the Showground except as approved by the RAS.

## PARASITES

19. Exhibitors must ensure that all Exhibits are free from all parasites before they are brought onto the Showground.

## PIG PASS

20. A PigPass National Vendor Declaration (PigPass NVD) form is required and must be presented at Inspection of Exhibits upon arrival.  
Prior to departure from Sydney Showground, Exhibitors must obtain a PigPass from the Pig Coordinator.

## PROTESTS AS TO AGE

24. Any protest as to the age of an animal may be made to the RAS in the form presented by the RAS for that purpose. Any such protest shall be determined by the Council and the decision of the Council shall be final and binding upon all Persons affected thereby.

## RAS' RIGHT TO CANCEL AN ENTRY

25. The RAS shall have the right at any time to cancel the Entry of any Exhibit without assigning any reason therefore notwithstanding prior acceptance of such Entry provided that if any Entry be cancelled except for a reason for which the Exhibitor is responsible the relative Entry Fee upon cancellation of the Entry shall be refunded to the Exhibitor.

## RIBBONS

26. In a Single Class, each winner receives a ribbon.  
In a Single Class a ribbon or other evidence of a previous Award shall not be worn or displayed in the ring.

Subject to the Regulations, Prize Ribbons may be awarded throughout the Pig Section in accordance with the following table:

(a) Single Classes	
5 Exhibits and under:	up to 3 ribbons
6 to 10 Exhibits:	4 ribbons
11 to 15 Exhibits:	5 ribbons
and in addition in Classes of:	
16 to 20 Exhibits	1 HC ribbon

31 to 35 Exhibits	4 HC ribbons
Over 35 Exhibits	5 HC ribbons

Extra Highly Commended ribbons may be awarded at the discretion of the Judge.

- (b) Other than Single Classes as specified in individual Class headings.
- (c) As soon as practical after a ribbon has been awarded to an Exhibit it should be displayed conspicuously throughout the remaining period of the Show on the pen which has been allocated to such Exhibit.

- (d) Any Exhibitor who fails to comply with (c) above may at the discretion of the Committee be asked to explain his actions and may, if thought fit, have his Award for his Exhibit cancelled.

### **SICK OR DISEASED ANIMALS**

- 27. If, in the opinion of a qualified Veterinarian appointed by the RAS, an animal on the Showground shall be so injured or be so affected by sickness, disease or other ailment as to warrant its destruction or its removal from the Showground, or its removal from its current location to another location such as a quarantine or hospital area within the Showground, as the case may be, the RAS shall be entitled to have the animal destroyed and/or require the animal to be forthwith removed from the Showground and the Exhibitor, upon receipt of such notice, shall forthwith remove such animal and failing such removal within the time prescribed by the RAS, by written notice to the Exhibitor or representative on the Showground, the RAS may remove the animal or cause the animal to be removed and all costs and expenses of removal shall be borne by the Exhibitor and shall be refunded to the RAS.

Each such animal shall at all times be at the sole risk and responsibility of the Exhibitor, and Person or Persons removing the animal shall at all times be deemed to be the agents of the Exhibitor and all acts and omissions on the part of such Person or Persons shall be deemed to be the acts and omissions of the Exhibitor who shall indemnify and hold indemnified the RAS its servants and agents from all Claims whatsoever in respect of the animal whether by reason of any loss or injury to or caused by the animal or because of transportation, feeding or housing or otherwise howsoever.

### **STUD/SCHOOL BANNERS**

- 28. If, in the opinion of a qualified Veterinarian appointed by the Stud/School banners will be restricted to the mesh area above the pens and may be displayed upon arrival. Banners must be no larger than 1400mm in length and 540mm in depth and must not hang below the mesh area.

### **UNETHICAL CONDUCT**

- 30. Refer to the RAS General Regulations.

### **USE OF STOCK-BOARDS AND STOCK-CANES**

- 31. The other Livestock Committees recommend that whips should not be used on the RAS' Showground. Exhibitors are encouraged to use stock-boards and stock canes when handling animals.

### **WITHDRAWALS**

- 32. (a) No refund of Entry Fees will be made in respect of Entries withdrawn or disqualified after the Closing Day of Entry.
- (b) Withdrawal forms can be obtained from the Pig Coordinator at [piggoat@rasnsw.com.au](mailto:piggoat@rasnsw.com.au).
- (c) Notification of withdrawals of Exhibits must be submitted to the RAS not later than two days prior to the Exhibits day of judging.
- (d) Withdrawal forms reaching the RAS later than 2 days prior to the Exhibit's day of judging may be subject to a \$10 fine, unless they lodge a certificate with the Pig Coordinator before their judging day, to the effect that such non-Exhibition is caused by:
  - (i) the death of the animal or animals; or
  - (ii) contagious or infectious disease confirmed by a Veterinary certificate; or
  - (iii) any other reasonable cause acceptable to the Other Livestock Committee.
- (e) Non-payment of this fine may prevent the Person making an Entry from Exhibiting at future Exhibitions of the RAS and may be referred to the Disciplinary Committee.

1. Each entry is to consist of a pair of bacon type pigs, or boars, or both, under 9 months of age.
2. **Pigs selected must have first competed in the General Classes.**
3. Exhibitors to nominate ONE entry per Breed i.e. Landrace, Berkshire, etc. on the Application for Entry and select and advise the pigs to compete in this Class at the time of Inspection.
4. All pigs entered must be purebred and stud tattooed/ear notched.
5. A first place ribbon will be awarded to the best Exhibit of each breed i.e. Landrace, Berkshire, etc.
6. To be judged as a pair of bacon type pigs with their uniformity and evenness as a pair to be considered in the Exhibits comparison to the standards of the commercial requirements of the trade for bacon pigs at that time.
7. Each Group Judge shall select the Best Exhibit of each breed and they shall be brought forward to compete for the K H Harris Memorial Perpetual Trophy, which is to be determined by the consensus of both Judges.
8. In the event of a tie an independent person shall be brought in to determine the winner.

## CLASS 27 - PAIR OF PORK TYPE PIGS, OR BOARS, OR BOTH, UNDER 6 MONTHS OF AGE

### CONDITIONS

1. Each entry is to consist of a pair of pork type pigs, or boars, or both, under 6 months of age.

8. In the event of a tie an independent person shall be brought in to determine the winner.

In the 1870s the Society introduced regulations to govern judges and judging to ensure that Competition was consistent and fair, and the tradition of Perpetual Trophies dates back to this time.

The Perpetual Trophies are the most prestigious of all RAS awards. They have a dual function in recognising superior effort in Competition and commemorating people and organisations that have had a long and meritorious connection with the Society. Some of the trophies currently competed for were first won in 1911. Winners of Perpetual Trophies are permanently honoured, taking their place alongside past winners and becoming part of the ongoing tradition of the RAS.

The Perpetual Trophy Collection of the RAS is unique. It comprises a wide range of beautiful and elegant trophies that illustrate an extraordinary history of agricultural judging and the pursuit of excellence.
