RAS Members are eligible for a 25% discount on Entry Fees. RAS Members who are not financial at the time of submitting their Entry Fees will not be eligible for the entry discount.

RAS MEMBERSHIP BENEFITS

In order for Exhibitors to claim the RAS Member discount on Entry Fees for this Competition, Membership subscriptions must be paid and accepted by the RAS before entering this Competition, and details must be provided on your Application for Entry prior to submitting to the RAS. No adjustments will be provided after the Application for Entry has been submitted. The Membership Name must be:

- (i) where the Exhibitor is a single Person, the Exhibitor Name;
- (ii) where the Exhibitor is more than one Person or a partnership, one of the Persons forming that partnership; or
- (iii) where the Exhibitor is a firm or company, the Authorised Contact Person/Representative of that firm or company. Members who are not financial at the time of submitting their Entry Fees will not be eligible for the Entry discount.

Entry Fee reductions are dependent upon Class(es) being entered. Non-member Entry Fees apply for Exhibitors where they are not financial members of the RAS. Applicants acknowledge that a valid RAS membership number must be provided at the time of submitting their application in order to receive the applicable discount.

INCORRECT AND INCOMPLETE APPLICATIONS FOR ENTRY

A correction fee of up to \$20 may be charged by the RAS, at its discretion, for each Application for Entry which is incorrect or incomplete. If an Application for Entry is not rectified in accordance with RAS' requirements, the entry may not be accepted by the RAS.

CONDITIONS OF ENTRY

A condition of entering into the competition is strict adherence to the following 'Regulations':

- Conditions of Entry to Sydney Showground located at www.rasnsw.com.au;
- General Regulations; and
- Sydney Royal Alpaca Special Regulations in this Schedule.

These documents constitute the whole agreement upon which entries are submitted unless otherwise authorised by the RAS.

Applications for Entry in the name of deceased person(s) are not eligible.

The Exhibitor or Owner warrant that each animal exhibited by them or by their child/children/guardian is duly registered and either their property absolutely or is under their absolute care and control. The Exhibitor holds the RAS exempt from any liability in the event of any loss or damage from any cause whatsoever.

A refund of Entry Fees shall not be made unless a notification of withdrawal is received by the Small Livestock Events Manager by Friday 27 March 2026.

The RAS has the power to evict any Exhibitor from the Showground.

WITHDRAWALS

Withdrawals of Exhibits must be submitted by no later than 5pm on Friday 27 March 2026 for a full refund of Entry Fee.

The Alpaca Withdrawal Form can be found on the website: www.rasnsw.com.au/alpaca.

To withdraw an Exhibit after the closing date of entries, Exhibitors must complete the Alpaca Withdrawal Form, select the relevant Classes for withdrawal and submit to the Small Livestock Events Manager via email alpaca@rasnsw.com.au.

Withdrawals after Friday 27 March 2026 will not receive a refund.

WORKPLACE SURVEILLANCE ACT

RAS operates surveillance cameras from Sydney Showground security and these are located in and around facilities requiring security monitoring for the safety or security of individuals or property. RAS also has access to Sydney Olympic Park security cameras and vice versa. Please note that security camera monitoring is continuous and ongoing and it is deemed that a person, by entering the Showground, consents to this photographing, filming or taping. RAS strictly complies with the Workplace Surveillance Act 2005.

WORKING WITH CHILDREN

Exhibitors must comply with all applicable Working with Children Legislation.

Exhibitors over the age of 18 years, who are involved in a child-related role or have direct unsupervised contact with children, must produce evidence of Working with Children Checks to the Royal Agricultural Society of NSW, at least one (1) month prior to Competition.

ACKNOWLEDGEMENT, RELEASE AND INDEMNITY

Exhibitors acknowledge and agree that they and their animals attend the Showground at their own risk. Exhibitors are responsible for arranging their own personal accident insurance, or insurance for their animal, as they feel is appropriate. There are indemnities in the General Regulations which govern all competitions on the Showground, please refer to the General Regulations.

PREVENTION OF CRUELTY TO ANIMALS

All Exhibitors are required to comply with applicable New South Wales legislation, including but not limited to the *Prevention of Cruelty to Animals Act 1979 (NSW)*, *Prevention of Cruelty to Animals Regulation 2012 (NSW)*, *The Prevention Of Cruelty To Animals (Land Transport Of Livestock) Standards 2013 (NSW)*.

An Exhibitor or nominated Person shall at all times exercise reasonable care, control or supervision of their animal. An Exhibitor or nominated Person who brings an animal to the Show, shall have a duty of care for their animal and to the community. This includes the comfort, safety and welfare of their animal and the interactions of any animal, and with any other Person or animal, at any time, whilst on-site at the Show. As a public Show, Exhibitors acknowledge that all animals exhibited do not pose a danger to other animals or the Show community and consider the welfare of their animal prior to deeming it suitable for Exhibition.

Handling

Where the Person is handling the animal they shall not act in a manner which unreasonably, unnecessarily or unjustifiably inflict pain upon the animal. This includes acts that are deemed physical or psychological abuse.

PRIZES AND GST

The Australian Taxation Office has deemed that GST is payable on prizes if an Exhibitor is registered for GST and enters an Exhibit as part of a business enterprise.

The information an Exhibitor provides on the Application for Entry determines whether GST is applicable.

Any prize stated in this Schedule does not include GST.

GST will not apply:

- ❖ if an Exhibitor enters an Exhibit as a hobby or private recreational pursuit; or
- ❖ if an Exhibitor enters an Exhibit as part of a business enterprise, the Exhibitor has an ABN, but the Exhibitor is NOT REGISTERED for GST.
- ❖ if an Exhibitor enters an Exhibit as part of a business enterprise the Exhibitor is not entitled to an ABN as the business or enterprise is not operating in Australia.

GST will apply:

- ❖ if an Exhibitor enters an Exhibit as part of a business enterprise, the Exhibitor has an ABN, and the Exhibitor is REGISTERED for GST.

Where GST applies, the RAS will pay the prize money quoted in this Schedule plus 10% GST. The RAS will issue a recipient created tax invoice.

WARNING: *The Exhibitor must complete the **Tax Details** on the Application for Entry. Failure to do so will result in the RAS deducting 47% of the successful Exhibitor's prize money as Pay As You Go Tax (PAYG). The RAS recommends that the Exhibitor seeks professional advice before completing the Tax Details.*

PAYMENT OF PRIZE MONEY

Prize money for the Sydney Royal Alpaca Show will be paid by Electronic Funds Transfer (EFT). Exhibitors are required to provide their bank account details in person at the Alpaca Show Office during judging in order to receive any prize money awarded.

It is the sole responsibility of the Exhibitor to ensure their bank details are submitted accurately and on time. Prize money will only be paid to Exhibitors who have provided complete and correct bank details at the Show Office.

The RAS aims to finalise all prize money payments by the end of June. Any queries regarding unpaid prize money should be directed to the RAS Service Centre via email at competitions@rasnsw.com.au.

Any prize money left unclaimed, including where bank details have not been provided, for a period exceeding six months is deemed forfeited by the Exhibitor.

FLEECE DELIVERIES

All fleeces must be delivered or posted to arrive **no later than 4pm on Friday 6 March 2026** at the following address:

Each fleece must be securely packed in a strong, clear plastic bag and clearly labelled with the Exhibitor's name, Exhibit name, and Class number.

ACCOMMODATION

The RAS arranges a number of accommodation lockers within the Munro Pavilion to accommodate Exhibitors. Submitting an Application for Accommodation does not guarantee allocation of accommodation.

Accommodation available for Exhibitors onsite is extremely limited, so we urge our Exhibitors to plan accordingly.

To apply to stay in a locker, complete the Application for Accommodation and return to the Small Livestock Events Manager by **Wednesday 25 February 2026**.

If your Application for Accommodation to stay on the Showground is successful, you will receive an acceptance email from the RAS.

By accepting accommodation on the Showground, you agree to follow fire and safety regulations from RAS Staff, RAS Security, and Fire & Rescue NSW. Breach of any accommodation and fire regulation rules, or refusal to follow instructions, may result in Disciplinary Action under the General Regulations.

Due to Fire Regulations, a maximum of 2 Persons will be permitted per locker.

Onsite accommodation in the lockers is provided free of charge. However, if all huts are allocated, priority will be given based on the number of alpacas entered.

Persons under the age of 18 years are NOT permitted to stay overnight on the Showground unless accompanied by an adult.

ACCESS TO THE SHOWGROUND

After Applications for Entry have been received and accepted by the RAS, and prior to the Show, Exhibitors will receive an Exhibitor Pack containing all materials they require to Exhibit at the Show. To gain access to the Showground when delivering Exhibits, all vehicles must present the bump-in pass and Show entry pass/ticket for each occupant in the vehicle to security personnel.

A Dashboard Slip will also be issued to Exhibitors with the Showtime Authorised Contact Person’s mobile number printed on the slip. A Dashboard Slip must be displayed on the dashboard of each vehicle at all times while on the Showground.

NO VEHICLE WILL BE ALLOWED TO PASS THROUGH SHOWGROUND GATES WITHOUT A BUMP-IN PASS AND A VALID ENTRY PASS/TICKET FOR EACH OCCUPANT IN THE VEHICLE.

TIME OF ARRIVAL

Wednesday 8 April 2026, between 6pm - 9pm, Thursday 9 April 6am - 8am, Thursday 9 April 2026, between 7pm - 9pm, Friday 10 April 6am - 8am & Friday 10 April 2026, between 7pm - 9pm
All Exhibits must be penned on the Showground by 9pm on Friday 10 April 2026.

All stock must be unloaded from vehicles as soon as possible on arrival. The vehicle once unloaded must immediately leave the Showground.

PAVILION OPENING TIMES

The Munro Pavilion will be open to the public at the following times. *Except on changeover days.*

From 9am to 7pm, Thursday 2 April to Monday 13 April 2026.

The Small Livestock Events Manager’s Office shall be open for Exhibitor Enquiries from 9am - 5pm.

INSPECTION DAYS

Alpacas will be inspected on arrival. **Wednesday 8 April 2026, Thursday 9 April 2026 & Friday 10 April 2026.**

Monday 13 April 2026 between

6am - 8am - In-pavilion access permitted for Bump-out.

All Exhibitors

Monday 13 April 2026 between

4pm – 6pm - External Vehicle access to Pavilion only (Parking along Northern Rivers Rd) - no vehicle access inside pavilion during these times - must be pre-booked via Event Manager at the Alpaca Office. Limited Availability.

7pm – 10pm - In-pavilion access permitted for Bump-out.

Exhibitors are welcome to stay onsite overnight Monday 13 April 2026 to depart Tuesday 14 April 2026 before 10am.

Preference for loading will be given to interstate Exhibitors and others or those travelling long distances.

These times will be strictly enforced. Exemptions to these hours must be requested via the Event Manager at the Alpaca Office.

DATES OF BIRTH FOR CLASSES RESTRICTED BY AGE

Stated hereunder is an explanation regarding Classes which restrict the eligibility of an Exhibit by the fact of its age. The dates shown within the parameters are those on, or between which, the Exhibit must be born to enable it to compete in the Class referred to immediately preceding the parameters.

Age of alpacas to be calculated from the birth date shown on IAR up to the day before halter judging commences.

Friday 10 April 2026 will be used as the reference date for all Classes.

6 months and under 12 months

(11 April 2025 – 10 October 2025)

12 months and under 18 months

(10 April 2025 – 11 October 2024)

18 months and under 30 months

(11 October 2023 – 10 October 2024)

30 months and under 48 months

(11 April 2022 – 10 October 2023)

PERPETUAL TROPHIES

Perpetual trophies remain the property of the Royal Agricultural Society of NSW. Ownership of the Trophy does not pass to the winning Exhibitor. A medallion will be presented to the annual winner whose name will be engraved on the Trophy.

SUPPORTER PRIZES

Prizes are provided by third parties, and the RAS advises that any such prize may be subject to change or amendment occurring at any time, thereby making the original information published incorrect.

ALPACA SPECIAL REGULATIONS

The General Regulations apply to all sections of the Show. These Alpaca Special Regulations apply to this section only. If there is any inconsistency between the General Regulations and these Alpaca Special Regulations, the Alpaca Special Regulations prevail. General Regulations are available from www.rasnsw.com.au.

INTERPRETATION

1. Unless the context indicates otherwise, the following definitions apply throughout these Regulations:

Words in the singular include the plural, and vice versa.

RAS refers to the Royal Agricultural Society of New South Wales.

Show refers to the 2026 Sydney Royal Easter Show.

Exhibitor means the individual on whose behalf and in whose name the Application for Entry is submitted and accepted by the RAS. This includes the Exhibitor's representatives and agents.

Person includes a firm, partnership, company, or corporation.

Show Society refers to a country pastoral and agricultural society or association.

AAA stands for the Australian Alpaca Association Ltd.

Produce Merchant means a merchant authorised by the RAS to supply produce at the Show.

Breeder, in relation to an animal, refers to the Person who owned the dam at the time the animal was born.

IAR refers to the International Alpaca Registry, which is owned and operated by the Australian Alpaca Association Ltd.

Pen, in the context of animal enclosures, may contain one or more animals.

A **Single Class** is a Class in which the Exhibit consists of one animal.

A **Group Class** is a Class in which the Exhibit consists of more than one animal.

APPLICATION FOR ENTRY

2. All entries must be submitted through the official online Application for Entry. The RAS may restrict the number of entries submitted by any one Exhibitor in both Animal and Fleece Classes if there is insufficient space to accommodate all Exhibits.

Each Exhibit may only compete in the Class selected at the time of Entry; changes or additions to Classes after submission are not permitted. All required information must be completed during the entry process, as incomplete applications may not be accepted.

In determining entry limits, the RAS will consider factors such as breed representation and the Exhibitor's past performance. Furthermore, only one fleece per animal may be entered in the Alpaca Fleece Competition.

ELIGIBILITY OF ENTRY

3. (a) The following alpaca breeds are eligible for competition: **Huacaya** and **Suri**.
(b) All alpacas over 6 months of age entered in halter Classes must be **registered** with the Australian Alpaca Association to verify breed integrity.
(c) No alpaca may be entered in a Class for which it is ineligible due to age. Any breach of this rule may result in disqualification and exclusion from further competition, following review by the Committee.
(d) Female alpacas 48 months of age or older are not eligible to compete unless they have produced a cria which is registered on eAlpaca.
(e) All handlers must be competent and capable of maintaining control of the animal at all times. Handlers under the age of 14 must be accompanied by a responsible person aged 18 years or older.

COMPLIANCE

4. The RAS of NSW Sydney Showground PIC number is: NJ464604

The onus is on individual property and stock Owners to comply with PIC requirements under Clause 7 of the Biosecurity (National Livestock Identification System) Regulation 2017.

ANIMALS NOT NECESSARILY ELIGIBLE TO PARADE OR COMPETE

5. The acceptance of an Entry by the RAS and/or its inclusion in the printed Catalogue does not, in itself, make an animal eligible to parade or compete in a Class. Any animal that becomes ineligible for its entered Class by judging day must not compete in that Class. The RAS reserves the right, at its discretion, to transfer an animal from a Class for which it is ineligible on judging day to a Class for which it is or has become eligible.

IAR REGISTRATION

6. All Exhibitors intending to participate in this Show must ensure that their animals are registered on the IAR at the time of Entry. Entries for animals not registered at the time of processing will not be accepted.
Entries must be submitted under the name of the Owner as recorded in the IAR at the time of Entry. Only the registered Owner or stud is eligible to Exhibit the animal.

ANIMALS THAT ARE NOT ENTIRE

7. An animal, whether male or female, is not eligible for Exhibition if it is not entire. Male animals may also be deemed ineligible if judged to have undeveloped or undersized testes.

RAS' RIGHT TO CANCEL AN ENTRY

8. The RAS reserves the right to cancel any Exhibit Entry at any time, without providing a reason, even if the Entry has previously been accepted. However, if the cancellation is not due to any fault of the Exhibitor, the corresponding Entry Fee will be refunded.

NOMINATIONS OF EXHIBITOR APPOINTED AS JUDGE

9. If, after the closing date for entries, an Exhibitor is appointed as a Judge in a section in which they have entered one or more Exhibits, those Exhibits will no longer be eligible to compete or parade in the judging ring for that section.

EXHIBITS AND JUDGES

10. An Exhibitor must not present an animal for exhibition if the Judge has directly or indirectly owned, leased (either solely or jointly), or handled the animal within six (6) months prior to the date of the Show. An Exhibit will be considered to be owned or leased by a Judge if, during the preceding six months, the Judge or any of the following individuals have held an interest in the animal: the Judge's spouse, children, parents, siblings, grandchildren, or the parents of the Judge's spouse.

A Judge must not:

- (a) Judge an Exhibit that they directly or indirectly own or lease, either alone or jointly with another party;
- (b) Act as a handler or Exhibit an animal at a Show where they are officiating as a Judge.
- (c) Knowingly judge an Exhibit that is entered in breach of this Regulation.

An Exhibit that causes or is likely to cause a breach of this Regulation will be disqualified, effective from the first day of the Show.

The decision of the Judge shall be accepted as final.

EXHIBITION PASSES

11. Exhibitors will be allocated passes as follows:

1 - 4 alpacas	1 pass
5 - 8 alpacas	2 passes
9 -15 alpacas	3 passes
16 alpacas or more	4 passes

Schools may be issued with a maximum of 10 passes at the discretion of the Small Livestock Events Manager.

* Please Note: **NO** extra passes other than those allocated as per the above specification will be issued.

PROHIBITED SUBSTANCES

12. Exhibitors must refer to the General Regulations, available at www.rasnsw.com.au.

A Treatment Notification Form must be completed and submitted if a Prohibited Substance has been administered to an Exhibit within the following timeframes prior to the Day of Exhibition:

- i. For hormones, synthetic hormones, corticosteroids, and anabolic steroids: **within 180 days**
- ii. For all other substances: **within 14 days**

The form must be signed by a qualified veterinarian and submitted to the office of the Small Livestock Events Manager **by 5pm on the day before the Day of Exhibition**.

DRUG TEST RESULTS

13. Exhibitors are advised that, in the event of a positive result arising from a drug test, the relevant alpaca association or society may be notified by the RAS.

UNETHICAL CONDUCT

14. Refer to the General Regulations.

DISCIPLINARY MATTERS

15. Refer to the General Regulations.

AGE OF ALPACAS

16. The age of alpacas will be calculated based on the birth date recorded in the IAR, up to 10 April 2026. The age of the fleece will be determined by the alpaca's age at the time of shearing.

FODDER

17. The RAS appoints an Official Produce Merchant to manage the sale of fodder on the Showground before, during, and after the Show. The fodder store will be open to receive orders from five days prior to the first day of the Show until the final day of the Show.

No other individual, firm, or company is permitted to sell or deliver fodder to the Showground at any time.

It is the responsibility of each Exhibitor to arrange their fodder requirements directly with the Official Produce Merchant, who will supply all standard lines of pre-mixed feed as needed.

Home-grown fodder brought exclusively for an Exhibitor's personal use will not be admitted to the Showground after the penning date.

Any Exhibitor found, to the satisfaction of the Committee, to be selling fodder to another Exhibitor will be reported to the Committee, which will take appropriate action as deemed necessary.

The Official Produce Merchant is required to report any breach of these Regulations to the RAS.

BEDDING

18. A base of sand will be laid down in each pen prior to arrival. Exhibitors may bring their own straw at the time of bump in or prearrange for the onsite fodder merchant to deliver straw to the Pavilion. No straw may be stored in the Pavilion; this means that subsequent straw will need to be purchased onsite. Shade cloth may also be used on top of the sand or straw if desired.

PROHIBITED IN PAVILION AND ON THE GROUNDS

19. Scooters, skateboards and bikes and not permitted on the Showground or in the Pavilions.

STORAGE OF FLAMMABLE LIQUIDS

20. The storage or use of flammable liquids within or near the Pavilions is strictly prohibited.

ELECTRICAL ITEMS

21. Any electrical devices brought onto the Showground including power boards and extension leads must be tested and tagged. Exhibitors are responsible for ensuring all tags are current and valid.

Electrical equipment found without appropriate tagging will be disconnected.

TRAVEL PERMIT

22. Interstate Exhibitors are responsible for ensuring they have the correct travel documentation required by their home state. This includes obtaining a Permit to Travel from their state's Stock Branch prior to dispatching animals to the Showground.

Onsite veterinarians can sign off on travel documentation if required.

ONLY EXHIBITS TO BE BROUGHT ON TO GROUND

23. No animal may be brought onto the Showground unless it is an accepted Exhibit with a confirmed Application for Entry by the RAS, except with prior approval from the Steward-in-Chief. Additionally, animals not entered for exhibition may not be displayed or offered for sale on the Showground without express permission from the RAS.

INSPECTOR'S VERIFICATION OF TYPE, DESCRIPTION AND ELIGIBILITY

24. All animals will be subject to inspection upon arrival. Inspections will be conducted by Inspectors appointed by the RAS. The Chief Steward will advise the order and approximate time of inspections. Exhibitors must be present with their animals during the inspection.

(a) All alpacas must be registered with the Australian Alpaca Association Inc. and must carry an approved brass ear tag displaying the alpaca's IAR or NLIS number.

(b) If an animal does not have an IAR or NLIS tag present, the Exhibitor must provide official confirmation from the Australian Alpaca Association that the tag was recently lost and that a replacement has been ordered and paid for prior to the Show.

(c) Male alpacas must be entire to be eligible for Exhibition. All genitalia must be complete, properly formed, and proportioned for normal reproduction.

(d) Huacaya alpacas must have a minimum fleece length of **20mm**. Those aged 12 months or older must be shorn regularly, with no more than **14 months of fleece** carried at the time of showing.

(e) Suri alpacas must have a minimum fleece length of **30mm**, which will be assessed during judging. First-fleece Suris must carry no more than **18 months of fleece**, while second and subsequent fleeces must carry no more than **14 months**.

(f) Inspectors will report on each animal regarding the following criteria:

- i. Whether the animal is of sufficient quality and merit to be a worthy Exhibit in its entered Class(es);

- ii. Whether the animal bears all identifying markings (e.g., colour, tattoo, microchip) as stated in the Application for Entry, and no markings not listed;
- iii. Whether the animal is presented in its natural conformation and complies with Special Regulation 7;
- iv. Whether the animal's age appears consistent with that declared in the Application for Entry;
- v. Whether the animal shows signs of illness, injury, or infection;
- vi. Whether the animal displays any genetic abnormalities;
- vii. Whether the animal is free from apparent footrot;
- viii. Whether the animal is free from visible external parasites.

(g) Inspectors are not required to provide reasons for their determinations to Exhibitors, and no appeals against these determinations will be accepted. However, the Steward-in-Chief or Assistant Steward-in-Chief of the Alpaca Section may override an Inspector's decision and permit the animal to remain on the Showground, with or without the right to be paraded or exhibited.

PARASITES

25. Exhibitors must ensure that all animals are completely free of external parasites before being brought onto the Showground.

SICK OR DISEASED ANIMALS

26. If, in the opinion of a qualified Veterinarian appointed by the RAS, an animal on the Showground is injured or affected by illness, disease, or any other condition that warrants its destruction, removal from the Showground, or relocation (e.g. to a quarantine or hospital area within the grounds), the RAS reserves the right to take such action. The Exhibitor will be notified and must immediately comply with the directive. If the Exhibitor fails to act within the timeframe specified by the RAS, the RAS may proceed with the removal, and all associated costs will be the responsibility of the Exhibitor and must be reimbursed to the RAS.

At all times, the animal remains the sole responsibility and risk of the Exhibitor. Any person involved in the removal of the animal will be considered an agent of the Exhibitor, and their actions or omissions will be deemed those of the Exhibitor. The Exhibitor shall indemnify and hold harmless the RAS, its staff, and agents from any claims arising from or related to the animal, including but not limited to injury, loss, transport, feeding, or housing.

Exhibitors must not, to the best of their knowledge, present any alpaca showing signs or symptoms of disease at the time of Exhibition.

All animals must adhere to the strict movement and quarantine areas.

HOSPITAL PENS

27. Exhibitors or individuals responsible for the care of animals who require the use of a hospital pen for sick or pregnant stock must submit a request to the Small Livestock Events Manager or the RAS Alpaca Committee.

PENS

28. Each pen must house a minimum of one and a maximum of three alpacas. A double pen may accommodate up to seven alpacas. Triple pens are not permitted, as they compromise structural stability and pose a safety risk.

CARE AND CONTROL OF EXHIBITS

29. All alpacas must be fed and cared for by the Exhibitor, who is also responsible for maintaining the cleanliness and overall condition of the pens while the animals remain on the Showground. Exhibitors are subject to the direction of the RAS Staff of the Section, as appointed by the RAS.

All Exhibits must be fed and their pens cleaned by 7am daily. Should any alpaca be found unfed or any pen in an unsatisfactory condition at any time, RAS Officials will attend to the animal and its pen. The cost of such feed and care will be charged to the Exhibitor responsible.

Any Exhibitor who fails to properly feed and care for their alpacas during the period of the Show may be subject to disqualification, following an inquiry by the Committee.

Exhibitors must supply their own feed, as well as feed and water containers. These containers must be positioned at least 45cm above ground level.

No alpaca may be removed from its designated pen, except for cleaning or judging purposes without prior approval from the Chief Steward.

Each Exhibitor is deemed responsible for the condition and presentation of their Exhibit while it is housed in the pen.

ANIMAL MOVEMENTS

30. All animals must remain in their allocated pens and may only be moved with the approval of the Chief Steward. Once penned, animals may be exercised in a designated exercise area, subject to the Chief Steward's permission. During Pavilion open hours, animals must remain in their pens unless they are being presented in the judging ring for participation in a Class.

DISPLAY OF EXHIBITS IN PAVILION

31. Exhibits must remain in their allocated pens at all times. Exhibitors are not permitted to move any Exhibit from its assigned pen without authorisation. All Exhibits will be on public display while the Pavilion is open. Inner aisles may be temporarily cordoned off during judging to ensure safe access to the Exhibits.

SIGNAGE AND DISPLAYS

32. All signage and display materials, including banners, signs, boards, and decorations, must be positioned safely and appropriately. They must not obstruct exits, egress points, thoroughfares, or walkways, and must be of reasonable size. Stall decorations or curtains must not extend above the top of the module and must not hang more than 50cm in depth. Exhibitor or Stud name boards must not exceed dimensions of 1.5m x 2m. The display of sales signage, ribbons or Awards from other shows, and advertising or banners outside the designated pen area is strictly prohibited. Sponsor signage is

not permitted within the Pavilions unless prior written approval has been granted. Exhibitors are responsible for any damage caused by affixing signage or other items to RAS property, including lockers, lockers, lofts, tack boxes, and stalling equipment, and must cover all associated repair costs. The Committee reserves the right to request the removal of any signage deemed excessive in size or inappropriately positioned. Failure to comply with these requirements may result in action taken by the Steward-in-Chief or Assistant Steward-in-Chief, at their discretion.

IDENTIFICATION OF EXHIBITS

33. Each Exhibitor in a Single Class must prominently display a catalogue number card while parading before the Judge. This number must correspond to the Exhibit's assigned number in the official Catalogue and be worn clearly on the handler as directed by the RAS. Catalogue numbers will be issued following completion of inspections. All handlers must be competent in managing the animal they are presenting; if deemed otherwise, the Judge may request their removal from the ring.

RATIONALISATION OF CLASS NUMBERS

34. The Chief Steward may, at their discretion, reallocate animals between colour Classes within any section (junior or senior) to balance Class numbers.

A minimum of three entries is required for a Class to proceed. If Entry numbers are insufficient, Classes may be combined.

ATTIRE

35. All handlers present on judging and inspection days must be appropriately dressed in clean, official AAA black uniforms, paired with black pants or a skirt, and boots or sturdy shoes. Clothing must not display any additional insignia, logos, or descriptive messages.

Exhibitors and any individuals handling animals, including during washing or preparation, must wear suitable footwear at all times to minimise the risk of injury.

JUDGING

36. Competitors must not discuss their alpacas or proposed Exhibits with the Judge prior to or during the Show, until all judging has been completed. The Judge's decision is final and not open to appeal. An Exhibit will not receive an Award if, in the opinion of the Judge, it is not of sufficient merit.

RIBBONS

37. No ribbon or other indication of a previous Award may be worn or displayed in the ring during judging of a Single Class. Subject to the Regulations, prize ribbons may be awarded throughout the alpaca section in accordance with the following Schedule:

Extra highly commended ribbons may be awarded at the discretion of the Judge.

- (b) This applies to Classes other than Single Classes, as specified in individual Class headings.
- (c) Once a ribbon has been awarded to an Exhibit, it should be prominently displayed on the pen allocated to that Exhibit for the remainder of the Show, as soon as practicable.
- (d) Exhibitors who fail to comply with clause (c) may be required by the Committee to explain their actions. At the Committee's discretion, the Award may be withdrawn.

CHAMPIONSHIPS

38. In awarding the Reserve Championship, the first prize winner in each Class in the relative subsection, other than the Exhibit to which the Championship has been awarded, shall be eligible to compete, together with the second prize winner in the Class in which the Champion was awarded first prize.

ANIMALS ADMITTED TO JUDGING RING

39. Only animals entered as Exhibits in a Class may be admitted to the judging ring during the judging of that Class.

EXHIBIT UNWORTHY OF AN AWARD

40. An Exhibit will not be granted an Award if, in the opinion of the Judge, it does not meet the standard deemed worthy of recognition.

PENALTY - NON-EXHIBITION OF ALPACA

41. (a) An Exhibitor who submits an Entry but does not present the Exhibit will incur a fine of \$50 per unrepresented Entry, unless the Exhibitor or their authorised agent provides written notice to the RAS before judging begins for the relevant Class, stating that the non-presentation is due to one of the following:

- i. The death of the animal(s),
- ii. A contagious or infectious disease, supported by a veterinary certificate, or
- iii. Any other reasonable cause deemed acceptable by the Alpaca Committee.

- (b) Failure to pay the fine outlined in (a) will result in the Exhibitor being barred from participating in future RAS Exhibitions.

PROTESTS

42. All protests must be submitted to the RAS in writing within one hour of the conclusion of the relevant Class. Any concerns raised will be reviewed and determined by the Council, whose decision shall be final and binding on all parties involved.

GRAND PARADES

43. All Exhibits on the Showground must participate in the Grand Parades if directed by the Chief Steward, RAS Staff or RAS Councillors.

All Exhibits participating in a Grand Parade must be in the charge of a competent handler and be properly controlled at all times. White dust coats and bush style hats must be worn.

CONDITIONS FOR PRIVATE TREATY SALE OF ALPACAS

44. Any Selling Agent or Exhibitor who offers for sale, sells, agrees to sell, or completes a sale of an alpaca located on the Showground or of an alpaca after it has left the Showground but before reaching its intended destination, must notify the RAS of the sale. A fee of \$20 or 1% of the gross sale price, whichever is greater, must be paid to the RAS in respect of each such transaction.

MOST SUCCESSFUL POINT ALLOCATION

45. Points will be awarded to the top five placings in each Class as follows:

For the five highest Awards in each Single Class, points shall be allocated on the basis of 5, 4, 3, 2 and 1.

If fewer than five Awards are made, points will be allocated in descending order of merit (e.g. three entries = 5, 4, 3 points).

Where a placing is not awarded, the next placing will receive the points of the following position. For example, if no first place is awarded, second place will receive points for third place, third place will receive points for fourth place, and so on.

Additional points are awarded as follows:

- 5 points for any Champion
- 3 points for any Reserve Champion
- 5 points for any Grand Champion
- 5 points for Best in Show

These points are cumulative. For example, an Exhibit that wins its Class, Champion, Grand Champion, and Best in Show will receive a total of 20 points.

The Exhibitor with the highest total points will be declared the Most Successful Exhibitor. In the event of a tie, the Exhibitor with the greatest number of first places will be the winner. If a tie still remains, second and third placings will be considered.

Points for any one Entry will be awarded to only one Exhibitor. In cases of joint ownership, points will be awarded to the Owner who submitted the Entry. If the Exhibit is jointly entered, points will be awarded to the nominee Owner listed on the IAR.

 - Animals are to be led individually into the ring in a clockwise direction in numerical order, one, two, three, four (1, 2, 3, 4) and lined up as per normal halter Classes in frontal profile. The Competitors will be allowed to observe the animals as they are being paraded to assess gait and conformation. The parade diagram must allow for clear visual of gait and conformation by use of straight lines in their parade.
 - Timing commences at the point all animals are lined up in the ring.
 - Competitors will inspect the animals over a period of ten (10) minutes from rear, frontal and lateral profiles, allowing half a minute for the alpacas to be stood in lateral profile, to be collectively and comparatively assessed.
 - Time will be called two (2) minutes prior to the completion of the allocated time.
 - Competitors' Placing Cards to be handed in at the conclusion of ten (10) minutes.
- Process of Oral Judging for Halter Class:
 - At the discretion of the Judge based on points from the visual judging, a minimum of 8 Competitors from the visual judging will participate in the oral judging. Reading from notes is discouraged at state finals.

- b. Before the commencement of the oral presentation, each Competitor is required either to give instruction to the Ring Steward or, to place the ribbons on the animals in placement order. The ribbon colour order being Blue - First (1st), Red - Second (2nd), White - Third (3rd), Yellow - Fourth (4th).
 - c. Each Competitor in the Oral Judging is allowed two (2) minutes to speak, explaining their placing from their nominated group of animals. Penalty points apply - One (1) point should be deducted for every ten (10) seconds or part thereof over the allotted two (2) minutes.

ALPACA YOUTH PARADERS SPECIAL REGULATIONS

1. Judging for this Competition will follow the AAA Youth Paraders judging standards.
2. One entry includes all Classes a single alpaca and handler pair within one division.
3. Animals may be bumped in between 6am and 8am on Thursday 9 April 2026. Alpacas must be penned by 8am on Thursday 9 April 2026.
4. To be eligible for the Championships and/or Trainer Award, competitors must compete in both the Showmanship and Stockmanship Sections.
5. The Chief Steward has full authority over Class determinations, eligibility, and disqualifications. Classes within a division may be split, combined, or cancelled. Preliminary and Open Divisions will not be merged.
6. Stud or school banners may be displayed in accordance with Alpaca Special Regulation 32 in this Schedule.
7. Bump out for Alpacas is between 6pm and 8pm on Thursday 9 April 2026. Removal of alpacas outside these times requires prior approval from the Chief Steward.

ALPACAS USED IN THIS COMPETITION

1. All alpacas used in the Youth Paraders Competition must be either owned by the competitor or borrowed with the prior consent of the alpaca's Owner. Loan animals may be available through the NSW Alpaca Youth Group. To be eligible for the Trainer Award an alpaca may only be used by one competitor in any given competition.
2. Alpacas may be shared between competitors in either the Preliminary or Open Divisions by prior arrangement. However, no alpaca may be used more than twice in any one Class within its age group. A minimum of four entries in a Class is required for an alpaca to be used twice.
3. All alpacas must be at least six months old on the date of the Show.
4. Presentation is considered in judging. Animals should have a body condition score of 2.5 or higher and be presented to Show standard. Obvious conformation faults may result in a deduction of up to three penalty points in any division.
5. Alpacas must be shown in a clean, well-fitted halter. A buckled halter is mandatory and must be used with a detachable lead.
6. Alpacas may be exhibited in either short or full fleece, provided the fleece length complies with the limits specified in Alpaca Special Regulation 24 of this Schedule.

ATTIRE

A minimum standard of safe clothing is compulsory for all Youth Paraders Classes. This includes closed toe shoes, long trousers, minimal or no loose jewellery, and tidy hair that is secured away from the face.

1. Showmanship Section: Black Trousers, Collared shirt or full school uniform.

ALPACA ARTS & CRAFTS SPECIAL REGULATIONS

The General Regulations apply to all sections of the Show. These Alpaca Arts & Crafts Special Regulations apply to this section only. If there is any inconsistency between the General Regulations and these Alpaca Arts & Crafts Special Regulations, the Alpaca Arts & Crafts Special Regulations prevail. General Regulations are available from www.rasnsww.com.au. Copies of all Regulations are available from the Administration office at the Showground. General Regulations are also available.

Exhibitor Rules:

1. Exhibitors must ensure that their entries are entered in the correct Class as transfers are only permitted at the discretion of the Committee.
2. Exhibitors will be allowed only one entry in any one Class unless otherwise specified.
3. Each Exhibit must be the work of the individual Exhibitor.
4. An Exhibit cannot be entered in more than one Class.
5. Works which have been accepted for Exhibition at a previous Sydney Royal Easter Show will not be eligible.
6. All Exhibits must have been completed within 18 months prior to the first judging day of the Show.
7. Novice Classes are open only to Exhibitors who have not won a first prize in a similar Class within that category section, at a previous Sydney Royal Easter Show.
8. An Exhibitor's age is determined as of the first day of the Show, Thursday 2 April 2026.
To be eligible for Junior Classes, Exhibitors must be under 18 years of age on that date.

Entry Requirements:

9. Soiled or damaged work will not be accepted.
10. No factory-made goods will be allowed unless otherwise specified.
11. Except where otherwise specified, articles may have seams and hems machine sewn, but all decorative work must be handwork.
12. Exhibits intended for display only will not be received.
13. An identification label will be posted to all Exhibitors approximately two weeks prior to the Show. These labels must be visible on delivery of Exhibits.
14. No extra props to be submitted except where otherwise specified.
15. At the discretion of the Committee or Judges, Exhibits considered not up to an appropriate standard will not be displayed.
16. Notices will not be allowed on any Exhibits except where required in a particular Class.
17. Should entries be so numerous that available space is not sufficient to display all entries, the Committee reserves the right to display sufficient only for the purpose.

Protest Procedures:

18. An Exhibitor, Attendant, or Competitor may enter a protest against any decision, act, or omission on the part of a Judge, the RAS, or any Official of the RAS in connection with the judging of a Class.
19. A protest must be in writing, set out the circumstances relied upon, and be accompanied by a fee of \$100. This amount shall be forfeited to the RAS if the protest is not upheld.
20. Protests must be lodged to the Small Livestock Events Manager by 12pm on the Friday 10 April 2026.
21. Protests will be heard and determined by the Alpaca Committee or Chairman of that Committee or Council at the upcoming Committee Meeting after Show.
22. Upon hearing and determining a protest, those hearing the protest may take and act upon such evidence as they think fit, regardless of the ordinary rules of evidence.
23. The determination of a protest is final and binding upon all parties, and there is no right of appeal.

Competition Eligibility:

24. A condition of entering into Competitions is strict adherence to the Regulations.
25. Applications for Entry in the name of deceased Person(s) are not eligible for entry, as are any applications deemed unauthorised by the RAS

Art Regulation:

These guidelines apply to all entries submitted across art and photography Classes. Please read carefully to ensure your work meets all requirements.

1. Entries must not display any identifying marks such as stud names, logos, or exhibitor names. Any entry showing these features will not be judged. If your piece includes identifying elements, they must be removed or fully covered prior to submission.
2. Presentation & Submission: All entries must be submitted as a single, complete unit, and be safely packaged for transport. Works must be finished, stable, and ready to hang or display. Incomplete or flimsy entries will not be accepted.
3. Hanging & Mounting: All framed or mounted works must include a secure hanging wire attached one-third from the top on the back. Only D-rings are permitted. Screw eyes, string, or twine are not accepted.
4. 2D Artworks: Includes paintings, drawings, and other flat artworks.
 - ❖ Any medium is permitted (e.g. pencil, paint, oil, ink, mixed media).
 - ❖ Must be framed or securely mounted without glass.
 - ❖ Size (including frame):
Minimum: 35cm (height or width)
Maximum: 1.83m (height or width)
 - ❖ Weight limit: 15kg
5. Sculptures: Sculptures must feature alpaca fibre as the primary material.
 - ❖ May include other materials (e.g. wood, wire) as a base or structure.
 - ❖ Must be stable, sealed, and fully finished.

- ❖ Model-making is not permitted.
 - ❖ Size limits:
Maximum height: 80cm
Base must fit within 40cm x 40cm
6. Photography: All photographs must be captured using a camera.
- ❖ AI-generated or synthetic images are strictly prohibited, including generative AI or AI-generated fill. Entries found to contain AI-generated content will be disqualified.
 - ❖ Canvas prints are accepted.
 - ❖ Entries mounted only on cardboard or corflute board without a proper frame will not be accepted.
 - ❖ Size limits:
Print size: Maximum 16 x 20 inches (41cm x 51cm)
Overall size (including frame): Maximum 20 x 24 inches (50cm x 60cm)
 - ❖ Weight limit: 15kg

Fibre Craft Regulation:

1. Fibre Craft Requirements
 - ❖ All Exhibits must be clean and unworn. Soiled or used items will not be judged or displayed.
 - ❖ Exhibit Identification Tickets must be securely attached with a safety pin.
 - ❖ All distinguishing labels or marks must be removed or covered.
 - ❖ Rugs must not exceed 180cm x 180cm.
 - ❖ Articles should be blocked where appropriate.
2. Materials & Samples
 - ❖ A sample of the original fibre, yarn, or tops must be attached to each Exhibit.
 - ❖ Commercial yarns are permitted where stated but must include labels or ball bands.
 - ❖ Exhibits without required samples will not be judged or displayed.
 - ❖ Alpaca blends must contain at least 20% alpaca.
 - ❖ All Classes are open to white, naturally coloured, or dyed fibre, unless otherwise specified.
 - ❖ Trims & Accessories may be used in small quantities to enhance an article (e.g. buttons, lace, zips, beads, ribbons).
 - ❖ Shank buttons, ribbon, beads, and twisted cord are not permitted in baby's wear.
 - ❖ Crochet is not permitted in hand knitting unless otherwise stated.
5. Spinning Classes
 - ❖ Lace weight Classes will differentiate between Huacaya and Suri alpaca.

- ❖ Commercially prepared fibre may be used, but no points awarded for preparation.
 - ❖ Skeins must be tied securely and presented to allow examination.
 - ❖ Yarn must be washed and free of grease.
 - ❖ State the intended purpose of the yarn.
 - ❖ WPI (wraps per inch) is defined as wraps per 2.5cm.
6. Knitting & Crochet Classes
- ❖ Machine knitting seams may be hand sewn or linked but not overlocked or machined.
 - ❖ Crochet and knitting entries must follow baby wear restrictions and blocking guidelines.
8. Felting Classes
- ❖ May include wet felting, nuno felting, and/or needle felting.
 - ❖ Fibre samples must be attached.

FIBRE CRAFT

DEFINITIONS:

Alpaca: A natural, luxurious fibre harvested from the alpaca. There are two fleece types:

Suri – long, lustrous locks

Huacaya – soft, crimp bundles

Article: An article is any individual handmade item. Items include but are not limited to scarves, wraps, hats, table runners, wall hangings or rugs etc. Unless otherwise stated, one article refers to a single item or a matching pair (e.g. one scarf or one pair of socks).

Blends: A blend is when alpaca fibre is mixed with other fibres to make yarn or fabric that's easier to work with and wear.

Commercial Yarn: Yarn that is made in factories using machines, purchased ready to use.

Where permitted, a sample and label (e.g. ball band) must be attached to the Exhibit.

Felting: The process of matting and bonding fibres together to make a dense fabric. It's often done using heat, moisture, and friction.

Garment: A finished piece of clothing made to be worn, such as a dress, pants, jacket, cardigan, or vest.

Lace: A style of knitting or crochet that creates open, airy patterns using holes and decorative stitches.

Nuno Felting: A special felting technique where fibres are felted into a lightweight fabric, like silk or cotton, to create a soft, textured material.

Novice: An Exhibitor with less than 18 months experience in the relevant craft.

Sample: A small piece of the yarn or fibre used in the Exhibit.

HAND SPINNING

Maximum of one entry per Class.

CLASS 710 – Skien of hand spun piled yarn in Suri alpaca, 19 WPI or fewer. Not less than 50g. Exhibitor to state intended use.

CLASS 711 – Skien of hand spun piled yarn in Huacaya alpaca, 19 WPI or fewer. Not less than 50g. Exhibitor to state intended use.

CLASS 712 – Skien of hand spun piled yarn in Suri alpaca, 11–14 WPI. Not less than 50g. Exhibitor to state intended use.

CLASS 713 – Skien of hand spun piled yarn in Huacaya alpaca, 11–14 WPI. Not less than 50g. Exhibitor to state intended use.

CLASS 714 – Skien of hand spun piled yarn in Huacaya alpaca, 8–11 WPI. Not less than 50g. Exhibitor to state intended use.

CLASS 715 – Skien of hand spun piled alpaca blend yarn (see definition), WPI open. Not less than 50g. Exhibitor to state intended use.

CLASS 716 – Skien of hand spun piled or single alpaca novelty yarn, WPI open. May include commercial tops or sliver, dyed or overdyed. Not less than 50g. Exhibitor to state intended use.

CLASS 717 – Skien of alpaca yarn using dyeing techniques (e.g. rainbow dyeing, cram pot dyeing, overdyeing). Commercially prepared alpaca permitted. WPI open. Not less than 50g.

In the 1870s the Society introduced Regulations to govern judges and judging to ensure that competition was consistent and fair, and the tradition of Perpetual Trophies dates back to this time.

The Perpetual Trophies are the most prestigious of all RAS Awards. They have a dual function in recognising superior effort in competition and commemorating people and organisations that have had a long and meritorious connection with the Society. Some of the trophies currently competed for were first won in 1911. Winners of Perpetual Trophies are permanently honoured, taking their place alongside past winners and becoming part of the ongoing tradition of the RAS.

The Perpetual Trophy Collection of the RAS is unique. It comprises a wide range of beautiful and elegant trophies that illustrate an extraordinary history of agricultural judging and the pursuit of excellence.
