2022 Sydney Royal Easter Show Breed Display Day – Tuesday 19 April 2022

The Royal Agricultural Society of NSW ('RAS') would like to invite you to apply for a breed stall at the Sydney Royal Easter Show. The breed stall day will be held on **Tuesday 19 April 2022** for one day only. The stall is required to be activated from 9.00am to 5.00pm. It is a good chance to promote your breed club and breed, as well as educate the public about responsible pet ownership. Please note that due to social distancing requirements, in 2022, spaces will be limited and pre allocated by the RAS depending on breed size. Please advise the size of your breed below, there may be a limit on the number of dogs we can accommodate depending on the breed.

Breed Stalls will be located at the Howie Pavilion. APPLICATION IS FREE! You will be provided benching modules for 3 -4 dogs for Giant or Large breeds (maximum), entry tickets for those attending, parking and a trestle table, free of charge. Stalls must be set up no later than 8.30am as the Pavilion opens at 9.00am to the general public. Locations will be pre allocated in 2022 and you will be informed of your location prior to attending. On arrival to the pavilion, you will need to advise the Dog Section staff in the Dog Office to confirm your arrival.

Dogs NSW will be supporting the 'Breed Stall Day' and the 2022 ADVANCE™ Sydney Royal Dog Show and will be awarding \$100.00 prize money each day for the following awards;

- Most Informative Breed Stand
- Best Breed Display

The Domestic Animals Committee request that you provide the office staff with a sample of all literature that will be available to the public at the stand as the RAS has certain sponsorship arrangements in place. Please note that retail sales are not permitted, the space is provided for educational and display purposes only.

- ❑ **PLEASE NOTE THIS IS AN EXPRESSION OF INTEREST.** Applicants will not be confirmed until a license agreement has been confirmed, returned and signed.
- ❑ Clubs are encouraged to bring along dogs and puppies (over 3 months) but they must have current vaccination papers and be registered with Dogs NSW or other Recognised Controlling Body.
- ❑ Stalls must be staffed during the hours that the pavilion is opened to the public. The Royal Agricultural Society of NSW will not take responsibility for any stall left unattended.
- ❑ Breed Clubs must provide its own material and equipment for the stall. Exhibitors are responsible for the safety and security of all their belongings in the space used and for the duration of that of that use. The RAS does not accept liability for any damage or loss of property which may occur.
