ROYAL AGRICULTURAL SOCIETY OF NEW SOUTH WALES ('RAS') PARKING CONDITIONS

1. All accidents or emergencies are to be immediately reported to security (24hr) on (02) 9704 1020.
2. The Exhibitor or person responsible for the vehicle ('the Occupant') agrees to read and obey parking conditions and will comply with directions from RAS Security and Sydney Olympic Park Authority ('SOPA') parking officers.
3. Parking pass or tickets must be on display inside the vehicle, RAS and SOPA officials will patrol the Carpark regularly to check vehicles and Occupants are meeting all requirements.
4. The speed limit is 10km/hr or any other speed limit imposed by the RAS or SOPA.
5. The RAS does not accept any responsibility for any loss or damage to any vehicle, its accessories, contents or other property or for the death or injury suffered to any person or animal. The Occupant indemnifies the RAS against any claims or loss or damage arising as a result of the Occupant's negligent act or omission.
6. The RAS may allocate alternative Space to the Occupant and the Occupant must locate any vehicle within marked bays within the Space. The period of occupation is at the sole discretion of the RAS and the RAS and SOPA reserves the right to fine, penalise or tow away any car, van, trailer, float or any other such vehicle, occupying the Space.
7. Parking is at the discretion of the RAS and may be revoked without explanation.
8. Vehicles must not block emergency egress doors or emergency vehicle access roads and are to give way to emergency vehicles and the Occupant must obey all emergency evacuation procedures.
9. Hosing down of vehicles is not permitted and all open top livestock trucks are to be covered before entering the site to prevent any run-off on the ground. Fines apply.
10. Sleeping is not permitted in the Space unless with the prior written approval of the RAS.
11. It is required that all Occupants conduct themselves in a decent and proper manner. Intoxicated persons may not be permitted to enter the Carpark.
12. Excessive noise is not acceptable between the hours of 9pm and 7am.
13. Closed circuit television surveillance is operated around the Carpark 24 hours/7 days a week.
