Heat Winners, Unplaced Semi-Finalists, and Finalists.—In addition to the prize money in each class, 10s. will be awarded to each heat winner and unplaced competitor in semi-finals. £1 will also be awarded competitors who are unplaced in finals.

A **Plumb Racing Axe** will be donated by **MESSRS. FAYETTE R. PLUMB, INC., PHILADELPHIA, U.S.A.** (Agent, Harold J. Beer, 364 Lonsdale-st., Melbourne, C.I.) to the winner of each Wood-Chopping event.
