Chopping and Sawing (Day and Night) will begin on Friday (Night only), 16th March, and continue throughout the Show, commencing at 11 a.m., 2 p.m., and 7.30 p.m., on Friday, Saturday, Monday (Day only), Tuesday, Wednesday, Thursday, Good Friday (Day only), Saturday, Monday, and Tuesday (Day only), 16th, 17th, 19th, 20th, 21st, 22nd, 23rd, 24th, 26th, and 27th March.
